- 7. A digital random draw will take place in accordance with State Government regulations. First prize will be allocated to the first ticket number drawn followed by all other prizes in descending order (for a complete list of prizes see the Schedule of Prizes below).
- 8. A separate draw for the Early Bird Prize and the Book Buyer's Prize will be held immediately before the Major Raffle draw (at 10.15am and 10.45am respectively) (together the 'preliminary draw'). The winning ticket number entered into either preliminary draw are eligible to be drawn again in the Major Raffle draw.

Entry

- 13.
